## 2025 DOZER DAY EVENT FOOD TRUCKS

**Saturday, May 3rd, 2025 from 11:00 a.m. to 4:00 p.m. &  
Sunday, May 4<sup>th</sup>, 2025 from 11:00 a.m. to 4:00 p.m.**

We invite you to join us at Dozer Day 2025 to sell your delicious foods and beverages! We plan to have 6 Daytime food trucks within the Dozer Day event space. Our demographic is families with children and we strive to keep our event “affordable” so **Please try keep your menu items under or around \$10.00 each.** Expect between 6,000 and 8,000 people to be attending the event based on 2024 attendance of 7,000. Event is held rain or shine. No refunds, unless your Food Truck is not chosen for the event.

### All food trucks must provide the following:

- Their own generator and water
- Current Mobile Food Service License through Panhandle Health District
- Insurance certificate showing Dozer Day/NUCA as additional insured (see attached example)

Only complete applications will be considered. Make sure all required forms and check for \$500.00 donation fee (request an invoice to pay via Credit Card) are included with submission. We will return check/refund payment if not selected.

Deadline for all materials to be completed and received is **March 31, 2025.**

Selections of Food Trucks will be made by the Dozer Day Vendor Committee and vendors will be notified by email by **April 10, 2025.** Decision of the Committee is final.

Committee will make selections based on:


- Variety of food offered (we will only have **ONE** vendor selling each type of food).
- Food prices (please have at least **one** item around \$10 and keep “family affordable” in mind)

In case of a food truck cancellation, we will contact runners-up and see if they are available. Refunds will not be made unless we are able to find a replacement Food Truck. We truly appreciate our **past Dozer Day Food vendors**, so they will be given **first right of refusal** for their category of food item.

## TYPE OF VENDOR

**Note:** EVENT reserves the right to not accept vendor menu that directly competes with another vendor

**Food Trucks** offer food that is prepared within their truck. All operations stay within the truck.

**Food Vendors** prepare and sell food from a 10x10 pop up tent. Operations cannot extend off the sides of the booth.

### BEVERAGE RULES:

- All food trucks and food vendors may sell any non-alcoholic beverages. All drinks and pricing must be included on menu submitted with application.

### CERTIFICATE OF INSURANCE:

- Provide a certificate of liability insurance for \$1,000,000 naming as Additional Insured: NUCA of Eastern WA & North ID / Dozer Day / Cabela's (see attached instructions).

### ELECTRICITY:

- Vendors are required to provide & use **QUIET** generators.

### PAYMENTS & FEES:

- **Flat Fee** – fee you pay for your space at the event. \$500 per space.
- \$35 fee will be assessed for any checks with insufficient funds or returned for any reason
- Failure to submit payments on time may forfeit your space in this event.
- Spaces are sold on a **first come first paid basis with preference given to past participants.**
- Payment options: check, pay by phone, virtual invoice, credit card.

### FIRE EXTINGUISHERS:

- All food trucks and food vendors deep frying must have **CURRENT** K-Type fire extinguishers with current service tags.
- Food trucks and food vendors that are not frying, must have a minimum of one, 2A:20BC and one K rated fire extinguisher.

### FOOD TRUCKS

- Food Trucks must have a minimum of one, 2A:20BC and one K rated fire extinguisher.

## HEALTH PERMIT:

- All food trucks and food vendors must apply and be approved for a Temporary Food Service Establishment Permit. Temporary Food Service Establishment Permit must be obtained by Vendor prior to set-up at EVENT. All Food trucks and food vendors **MUST DISPLAY** a SERVE SAFE CERTIFICATION. A copy of this certification must be given to the promoter prior to set up. Vendors will not be able to set up, if the promoter does not have the certification on file.

## Load-in & SET-UP:

- We **highly** suggest setting up your booth on the Friday before the event since no vehicles will be allowed on the Dozer Day site after 8 am Saturday May 3rd . Post Falls SWAT, Ambulance and Fire Truck vehicles arrive for set up and will block the entrance so this is a **FIRM time!!!** To further incentivize a Friday set-up, NUCA will be hosting an informal happy hour BBQ at 5pm, so we hope you can join us! If you should need help with transportation from the parking lot to your space after Friday, you must arrive 1.5 hours prior to opening (8:30 am). If you arrive after those times you may have to transport your items by hand.
- Food trucks and food vendors are required to check-in at event volunteer desk prior to loading-in and setting up. Event information will be provided via email no later than the Monday prior to the event.
- Food trucks and food vendors must claim their assigned booth space no later than 8:00 a.m. on Saturday morning or it will be forfeited.
- Food trucks and food vendors must be present and open for business during ALL event hours.

## MENU:

- Food trucks and food vendors are allowed to sell only menu items that were submitted during EVENT application process and approved during the selection process. Additional menu items not approved during the selection process need prior written approval from EVENT before they are eligible for sale.
- Prices of menu items are approved during the selection process. Changes to menu pricing are not allowed without prior written approval by the Selection Committee

## PHOTOGRAPHY & PROMOTION:

- Food trucks and food vendors agree to allow use of video and photography taken by event organizers at the event for promotional purposes.
- Any photos taken by the event are the property of the Dozer Day.

## PROPANE TANKS:

All vendors with propane tanks are required to bring all necessary equipment to properly secure them.

## **SAFETY & SECURITY:**

- Applicants shall sell and serve food at their own risk.
- Applicants must obey all pertinent safety codes and laws, including, but not limited to, fire, safety and parking regulations.
- EVENT reserves the right to shut down any vendors not meeting cleanliness and food storage safety codes and laws.
- Canopy tents must be fire retardant; open flames must be located a minimum of 10' away from all canopy materials.
- All canopies, tents and other temporary structures must be weighted before you are permitted to open, with the equivalent of 40 pounds per pole minimum. Booths may not open until properly weighted.

## **SPACE:**

- Food trucks and food vendors will abide by EVENT staff requirements regarding location(s). EVENT reserves the right to change a vendor location at any time.
- Food trucks and food vendors will provide all required equipment for operations and sales.
- Food trucks and food vendors A frame signs cannot extend further than 3 feet from façade of booth. Food trucks and food vendors are liable for any injury or damage caused by signs.
- Any food vendors that fry must be in a food truck only. Food vendors with a pop-up tent are NOT permitted to fry.

## **WASTE:**

- No grease or gray water disposal is available.
- No water provided by EVENT
- Food Snack & Food Trucks Vendors are responsible for removing debris and ensuring the general cleanliness of the area

## **WEATHER:**

- Dozer Day will take place rain or shine. Applicants agree to be present despite weather conditions. Each participant is responsible for prepare their displays to withstand weather fluctuations including rain and wind.

## **FOOD TRUCKS AND FOOD VENDORS ARE INDEPENDENT CONTRACTORS:**

Food trucks and food vendors execute this Agreement as independent contractors and shall at all times have complete supervision, direction, and control over the services to fulfill requirements. Vendors execute this agreement as independent contractors, not as an employee of EVENT. Vendors will assume responsibility for appropriate payment of payroll taxes and charges under applicable federal and local law. Vendors agree to take complete responsibility for paying the appropriate federal and state taxes as independent contractors.
